In addition to illustrating the unification power of models in different software domains, this part demonstrates applicability from different starting points (language, business knowledge, standard, etc.) and focuses on different software engineering activities such as Requirement Engineering, Analysis, Design, Implementation, and V&V. Each chapter concludes with a small set of exercises to help the reader reflect on what was learned or to dig further into the examples. Many examples of models and code snippets are presented throughout the book, and a supplemental website features all of the models and programs (and their associated tooling) discussed in the book.

Like other sciences and engineering disciplines, software engineering requires a cycle of model building, experimentation, and learning. Experiments are valuable tools for all software engineers who are involved in evaluating and choosing between different methods, techniques, languages and tools. The purpose of *Experimentation in Software Engineering* is to introduce students, teachers, researchers, and practitioners to empirical studies in software engineering, using controlled experiments. The introduction to experimentation is provided through a process perspective, and the focus is on the steps that we have to go through to perform an experiment. The book is divided into three parts. The first part provides a background of theories and methods used in experimentation. Part II then devotes one chapter to each of the five experiment steps: scoping, planning, execution, analysis, and result presentation. Part III completes the presentation with two examples. Assignments and statistical material are provided in appendixes. Overall the book provides indispensable information regarding empirical studies in particular for experiments, but also for case studies, systematic literature reviews, and surveys. It is a revision of the authors' book, which was published in 2000. In addition, substantial new material, e.g. concerning systematic literature reviews and case study research, is introduced. The book is self-contained and it is suitable as a course book in undergraduate or graduate studies where the need for empirical studies in software engineering is stressed. Exercises and assignments are included to combine the more theoretical material with practical aspects. Researchers will also benefit from the book, learning more about how to conduct empirical studies, and likewise practitioners may use it as a "cookbook" when evaluating new methods or techniques before implementing them in their organization.

For the second time, the European Software Engineering Conference is being held jointly with the ACM SIGSOFT Symposium on the Foundations of Software Engineering (FSE). Although the two conferences have different origins and traditions, there is a significant overlap in intent and subject matter. Holding the conferences jointly when they are held in Europe helps to make these thematic links

more explicit, and encourages researchers and practitioners to attend and submit papers to both events. The ESEC proceedings have traditionally been published by Springer-Verlag, as they are again this year, but by special arrangement, the proceedings will be distributed to members of ACM SIGSOFT, as is usually the case for FSE. ESEC/FSE is being held as a single event, rather than as a pair of colocated events. Submitted papers were therefore evaluated by a single program committee. ESEC/FSE represents a broad range of software engineering topics in (mainly) two continents, and consequently the program committee members were selected to represent a spectrum of both traditional and emerging software engineering topics. A total of 141 papers were submitted from around the globe. Of these, nearly half were classified as research papers, a quarter as experience papers, and the rest as both research and experience papers. Twenty-nine papers from five continents were selected for presentation and inclusion in the proceedings. Due to the large number of industrial experience reports submitted, we have also introduced this year two sessions on short case study presentations.

During the 18 months since the publication of the 1st edition the practice of software quality and the availability of tools and guidance for its implementation has increased dramatically. The emphasis on the need for formal methods has increased and calls for certification of safety critical software are now common. In particular this 2nd edition: -Expands the treatment of static analysis and includes a comprehensive but simple example in order to illustrate clearly the functions of each analyser in Chapter 8. -Describes formal requirements languages more fully in Chapter 6. -Updates the compendium of available guidelines and standards in Chapter 5. -Expands the description of the many high level languages in Chapter 9. -Improves and expands the exercise into a 49 page case study consisting of a documentation hierarchy for a safety system in Chapter 14. It is seeded with deliberate errors and ambiguities and now includes guidance in finding them.

Examines the current position of Computer Aided Software Engineering (CASE) in the software market, focusing on practical issues faced by users. Presents a comparison of CASE tools and contains recent debates as well as a look at its future. Coverage includes a review of the ISO IRDS, ISTE Applications Architecture, CASE tools utilized in designing database and much more.

The Pernambuco School on Software Engineering (PSSE) 2007 was the second in a series of events devoted to the study of advanced computer science and to the promotion of international scientific collaboration. The main theme in 2007 was testing. Testing is nowadays a key activity for assuring software quality. The summer school and its proceedings were intended to give a detailed tutorial introduction to the scientific basis of this activity and its state of the art.

These proceedings record the contributions from the invited lecturers. Each of

the chapters is the result of a thorough revision of the initial notes provided to the participants of the school. The revision was inspired by the synergy generated by the opportunity for the lecturers to present and discuss their work among themselves and with the school's attendees. The editors have tried to produce a coherent view of the topic by harmonizing these contributions, smoothing out differences in notation and approach, and providing links between the lectures. We apologize to the authors for any errors introduced by our extensive editing. Although the chapters are linked in several ways, each one is sufficiently self-contained to be read in isolation. Nevertheless, Chap. 1 should be read first by those interested in an introduction to testing. Chapter 1 introduces the terminology adopted in this book. It also provides an overview of the testing process, and of the types (functional, structural, and so on) and dimensions (unit, integration, and so on) of the testing activity. The main strategies employed in the central activity of test selection are also discussed. Most of the material presented in this introductory chapter is addressed in more depth in the following chapters.
